About Ratings

The ratings mentioned on this entry form are USATT ratings that players receive when competing in tournaments sanctioned by the USA Table Tennis Association (USATT). This is not a USATT sanctioned tournament, however we are using USATT ratings for seeding and for restricting better players from lower level events. The "Open Singles" event is open to any player, whereas the "U-1800" is restricted to players whose rating is under 1800. **Unrated players can enter any event**, however if you are a new player and have never played at a club, we recommend you enter the "U-1000" and/or the "U-800" event. If you do not have a USATT rating, but think you know your approximate level, enter it after "ESTIMATED RATING" below.
